3. **CONTRACTING OF SPACE – TIME SCHEDULE**
Space Applications: Companies interested in participating in **EXPOSOLIDOS'09** should fill out the "Admission requested form" or apply in writing to **EXPOSOLIDOS:** Travessera de Gràcia 96, 4rt 1º, 08006 Barcelona (Spain). A deposit of 50% of the total amount due should be sent together with the application form according to rule 7 above. Space reservation will be finished by 29th May, 2009.
Allocation of space: Once the space allocation has ended, a copy of the plan indicating the allocated space will be sent to each exhibitor.
4. **ADMISSION**
Admission: The **EXPOSOLIDOS'09** Organizer keeps the right to refuse a request for admission if the products are considered irrelevant to the Exhibition. In such cases, the money amount advanced will be refunded in full. On accepting exhibition space, the exhibitor is committed, both personally and on a behalf of those persons representing him, to comply with the administrative rules and regulation of assembly, security, advertising and others stipulated in the participation and Assembly Regulations of the Organizer.
5. **SPACE ALLOCATION**
Space allocation: The allocation of space is the exclusive right of **EXPOSOLIDOS'09** and will be carried out on the basis of technical considerations related to the exhibition as a whole and the materials to be exhibited. At all times, efforts will be made to take into consideration the number of square meters requested and, above all, the date of request. Circumstances may arise in which the organization finds itself obliged to alter an already assigned location, changing its place or modifying its dimensions, as well as access, exits, aisles, and the general plan of the hall, without the exhibitor having the right to demand any refund. If for some reason the Organizer cannot provide the exhibitor with the space reserved but allocates another of similar characteristics but of smaller size, the exhibitor will have the right to be refunded the difference between the amount paid for the space originally assigned and the cost of the space with which he is finally provided, to the exclusion of any further claims on the part of the exhibitor and without his being entitled to be paid any other indemnification for damages.
6. **PRICES and Value Added Tax**
Fees: For **EXPOSOLIDOS'09** the tariffs will be done depending on the kind of stand and the square meters. The exhibitor will be required to pay 16% of tax (IVA: Value Added Tax), applicable to the costs of his participation.
7. **CONDITIONS OF PAYMENT**
Conditions of payment: Payment will be made between the following deadlines: 50% with the space application. The remaining 50% must be paid on receipt of the corresponding invoice, and in any case no later than 29th May 2009, deadline to receive applications. All remaining payments (contracted services) must have been made before 2nd October 2009. The contracted services during **EXPOSOLIDOS'09** mantling will be recharged 20% extra and will have to be paid before 17th November 2009.
 The payments for contracting space and participation rights must be made by a deposit or bank transfer in favor of PROFEI, S.L. to the account IBAN: ES40 2013/1140/64/0200036909 (Caixa de Catalunya). Swift: CESCESBBXXX.
 The stand cannot be vacated until the exhibitor has satisfied all his payment commitments with **EXPOSOLIDOS'09**. In the case of delay in payment, **EXPOSOLIDOS'09** reserves the right to prohibit the removal of all materials from the stand and retain them as a guarantee. In such cases, it makes no difference whether the objects are property of the exhibitor or of third people. All expenses incurred by the application of these measures will be paid by the exhibitor. Furthermore, **EXPOSOLIDOS'09** assumes no responsibility for any damage that might be suffered by the materials held back as a guarantee.
Cancellations of space: Those exhibitors who have presented their admission Request or had this request approved can terminate the contract only according to the specific rules contained in the Contract Regulation of **EXPOSOLIDOS'09**, namely: if the exhibitor wishing to cancel his contract has already paid the initial 50%, this amount will be fully refunded if the cancellation is made before 29th May 2009. After this date, the Exhibition will retain the totality of the paid amount.
 In the case of an exhibitor who has not paid the full amount before the inauguration of the event or who has not occupied the contracted space hired, the Organization has the liberty to allot the space or stand to a third person and is under no obligation to compensate or refund the amounts already paid for this purpose.
8. **INSCRIPTION RIGHTS**
 The exhibitors shall pay 280€ (Added tax not included) as inscription rights. Are included: compulsory fire insurance, compulsory third part liability insurance, their presence in the Exhibitor's Catalogue and the Internet Pre-Catalogue, from the 15th July 2009.
9. **ADVERTISING DURING EXPOSOLIDOS'09**
Advertising in the fairground: it is not allowed to distribute outside the space rented brochures or any other advertising material, if there is not a Organization written permission.
10. **LEGAL QUESTIONS**
Prevention of accidents: Exhibitors have a duty to respect the legal regulations concerned with security of personnel, in particular with relation to the assembly and operation of machinery and the general safety requirements surrounding the operating of machines. The exhibitors are responsible for this security.
Damage to the Fair Precinct: The exhibitor is responsible for all damage caused in the Fair Precinct either by himself or by his employees.
Loss of or damage to Material Exhibited: The Exhibition assumes no responsibility and grants no indemnity for loss or damage to material exhibited, for whatever reason.
Cancellation of contract by EXPOSOLIDOS'09: The organization reserves the right to rescind contracts without prior warning whenever it can be legally proved that the exhibitor has committed or may commit unfair competition or any other infraction of established law. In no such case may the exhibitor claim indemnity rights.
 If **EXPOSOLIDOS'09** cannot be held due to circumstances beyond the organizers' control, such as force majeure, political events or government decisions, money will be refunded proportionally to the exhibitors and should a positive balance remain, part of the expenses still to be met.
 Spanish law shall prevail. L'Hospitalet de Llobregat will be the place of fulfillment and jurisdiction.
11. **PASSES, INVITATIONS AND STAND ATTENDING**
Passes : Each exhibitor is entitled to have passes for the personnel attending to his stand in proportion to its number of square meters (8 passes for stands less than 48 m² and 16 passes for stands more than 48 m²).
Control of entrance: Due to security reasons, exhibitors must show their badge each time that they entry to the Fair Grounds with the personnel identification number or similar.
Invitations: The Organization will give to the exhibitors electronic invitations to be sent by e-mail as well as printed invitations. In the case of printed invitations, the Organization will give 200 for stands less than 48 m² and 400 for stands with more than 48 m².
12. **ASSEMBLY AND DISMANTLING**
Assembly: From the 12th November to the 16th November 2009 (from 9:00 a.m. to 9:00 p.m.)
Dismantling : From the 20th to the 23rd November 2009 (from 9.00 a.m. to 8.00 p.m.). The modular stands provided by the Organization must be returned in the same condition as when they were hired. Any damage caused during the rental period will be paid by the Exhibitor.
Forbidden: is forbidden to take out goods or samples that are exhibiting in the stand during **EXPOSOLIDOS'09**, without an authorization of the organization.
 Fixing to the hall floor is not permitted.
13. **CONTRACTING SERVICES**
Contracting services: EXPOSOLIDOS'09 offers the possibility of contracting a variety of services. In the near future you will receive the Services Forms which will contain different offers and prices.
14. **INSURANCES**
Compulsory insurance: Civil Responsibility and Fire Compulsory Insurance are included in the payment of the contracted fee. We suggest to the exhibitors an owner insurance.
Robbery insurance: This insurance is obligatory and will be covered by the exhibitor. The Organization will contract an insurance for maximum 300 € per Exhibitor.
15. **TECHNICAL REQUIREMENTS**
Floor resistance: 5000 kg/m². Cost of installation and connection of the telephone, gas, water, electricity and compressed air, as well as the charges for their use and for whatever other services rendered, will be billed separately by LA FARGA.
Electrical Installations: electrical supply to the trades fair halls is three-phase and the voltage is 380 V and 220 V between phases and neutral.
 All the machines in working order during the event should comply with the European safety rules.

The non-completion of these rules will imply the stand close down and the loss of the exhibitor's rights. The Organization reserves the right to start legal actions in this case.
